Dear Legislative Leaders:

We write to express our dismay at the Governor's proposed budget cuts to programs that serve the most vulnerable Pennsylvanians. Funding cuts to mental health services, intellectual disability services, addiction treatment programs, services for people who are homeless, and the Homeowners Emergency Mortgage Assistance Program (HEMAP) program would have catastrophic consequences for our Commonwealth.

**We are especially troubled by the proposal to eliminate the General Assistance (GA) cash assistance program and slash funding for GA-related Medical Assistance.** These cuts will eliminate a lifeline for people in desperate crises. This is not how Pennsylvanians want our government to treat abused women, people with disabilities, orphaned children, and people struggling to overcome drug addictions. **We urge you to reverse these cuts in the final 2012-13 budget.**

General Assistance is a last-resort program providing extremely meager benefits to 68,000 Pennsylvanians with no income. There is no other safety net for its recipients: if someone is able to work or has another source of income, he or she is ineligible for GA. The overwhelming majority of recipients are individuals with physical and/or mental health disabilities; most of these individuals are applying for federal SSI disability benefits that will reimburse the Commonwealth once approved. GA also provides a lifeline to women escaping domestic violence. It supports people in intensive drug or alcohol treatment programs. And GA supports caregivers and children unable to live with their families.

The average \$205 monthly GA benefit is starkly low, but this small sum frequently keeps individuals from becoming homeless. With \$205 a month, many people on GA can rent a room. They can pay for the bus to get to needed appointments. This \$205 pays for clothes, co-pays, over-the-counter medicines, laundry, soap, and toothpaste. And this money is a lifeline enabling domestic violence victims to escape abuse. Without the prospect of income, victims have no option but to stay with or return to their abusers, enduring continued violence. Without GA, other people will turn to homeless shelters or end up in state psychiatric hospitals or jails/prisons.

Cutting GA also makes poor budgetary sense. For many recipients, GA operates as a loan program, whose benefits are repaid when their federal SSI benefits are approved. For others, \$205 a month in GA is far cheaper than the alternative costs Pennsylvania faces if these people are left destitute. These costs include homeless shelters (\$1,050 a month), foster care (\$600 - \$1,800 a month), incarceration (\$2,750 a month), and state psychiatric hospitals (\$20,584 a month).

Pennsylvanians are compassionate people, who want to ensure that people in dire need of financial support get the help they need. GA's meager benefits provide last-resort support. Eliminating that vital support would leave people with disabilities and people coping with abuse both destitute and hopeless. Pennsylvanians do not want such a cruel budget.

We urge you to reject the proposed elimination of the General Assistance program and cuts to GA-related Medical Assistance, as well cuts to as other programs that provide critical support for Pennsylvania families.
